- ❑ Social Security cards and/or ITIN letter for everyone listed on tax return
- ❑ 6419 Advance Child Tax Credit and 6475 Economic Impact Payment (EIP) stimulus letters (tax years 2020 and 2021)
- ❑ Childcare statement from all providers with address and tax ID# and/or SS# for childcare provider (or provide receipts with amounts paid)
- ❑ 1098s for education expenses paid, mortgage interest paid, property taxes paid and list of any other itemized deductions
- ❑ 1095-A for Marketplace Health Insurance Coverage
- ❑ Bank account and routing number for direct deposit
- ❑ Copy of prior-year tax return
- ❑ Identity Protection (IP) PIN Letter (CPOIA Notice)

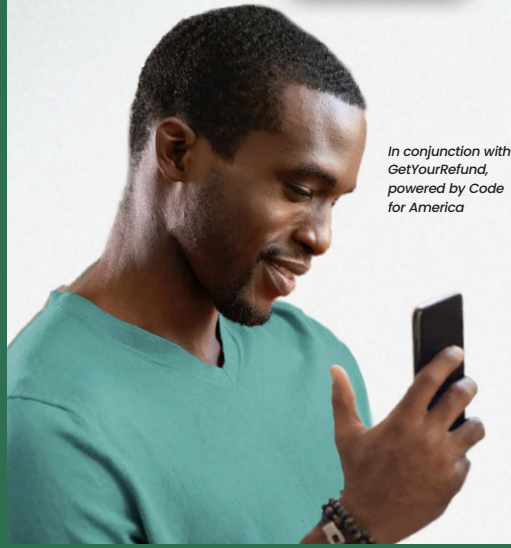
